CCCE-PAG Project Implementers gears up for the tasks ahead thru the CSO Mapping and Communication Planning Training-Workshop

Coming from a successful Launching Activity last January 12, the CCCE-PAG National Project Management Team (PMT) spearheaded the conduct of the CSO Mapping and Communication Planning training –workshop last February 17 – 19, 2016 at the PhilDHRRA Partnership Center . This 3-days training is a response to the capacity-building need identified in the previous project orientation activity particularly to "acquire basic knowledge and competence necessary for a meaningful take off of the project at the municipal and provincial levels" (J. Lopez).

The main objective of the training-workshop on CSO mapping is to develop the participants' competency in administering the following tools: a) CSO profiling, b) Capacity and Training Needs Assessment; and c) on encoding and utilizing the CSO database;

The second part of the 3-day activity focused on a workshop that aimed to deepen their understanding of the project by identifying the CCCE-PA G Key Messages (pre-Com Plan exercise) in relation to the key stakeholders. The last day was spent discussing more operational concerns such as project monitoring schemes and re-entry planning. As a result, consensus on key operational concerns and the Memorandum of Agreement (MOAs) with NGO Implementing Partners (INPs) was achieved.

Also on the first day of the training-activity, Ms. CCCE-PAG Project Jing Lopez, Manager, presented theproject's operational framework in a

sequential manner, clustered by project components leading to defined or desired results. Ms. Jen Javier, former PhilDHRRA Research Coordinator handled the session on CSO Mapping Tools - CSO Profiling and Capacity and Training Needs Assessment (CTNA) tools as well as the database building and analysis. This one-day session incorporated workshops and hands-on activities through which the participants learned the how's & why's of the tools, provided additional refinements and were clarified on the roles and responsibilities of the regional and provincial

implementing NGO partners (INPs).

The second day was spent concluding the session on CSO mapping tools and a tool in assessing the level of organizational development of CSO networks was introduced. Later on, the topic on Communication Planning, that is, communicating participatory and accountable governance as an essential aspect of development work, and communicating the key messages of the project itself to major stakeholders found the participants in a more pensive mood as they made an attempt to define CCCE-PAG's kev messages in more innovative and creative ways. Executive Director – CCJD with Ms. Girlie Alvares as co-speaker, guided the participants in the process mainly through workshops. However, the session served only as a "teaser", a prelude to a longer *Communication Planning* slated in the next

scheduled activity. According to Mr.Batario, working out specific and appropriate key messages and the various ways to deliver these messages addressed to identified major stakeholders: CSOs, LGUs, PHILDHRRA networks and the larger public may take some more time, thus, a separate activity on communication planning has been planned to accomplish this.

The last (3rd) day focused on discussing, clarifying and coming up with agreements regarding project operations concerns. The group, led by Ms. Jing Lopez (PM,CCCE-PAG), Ms. Caring Corridor (NC, PhilDHRRA) and Ms.Geline Quitario (FO, PhilDHRRA) took turns in explaining relevant proposals and policies addressing such operations and management concerns. Agreements as to Re-entry plans, training and M/E schemes as well
